2. (1) In these Regulations –

Interpretation.

"the Act" means the International Foundations Act, 2010;

"the Commission" means the International Financial Services Commission established under the International Financial Services Commission Act;

"dollar" or "\$" means dollar in the currency of the United States of America;

"Registrar" means the Registrar of International Foundations:

Fees.

First Schedule. 3. The fees set out in the First Schedule to these Regulations shall be charged for the registration, renewal, amendment, reinstatement, restoration, dissolution, continuance, discontinuance or other matters relating to international foundations.

Prescribed penalties.

4. The certificates issued by the Registrar in respect of an international foundation shall be substantially in the forms set out in the Second Schedule to these Regulations.

5. Where any provision of the Act creates an offence and provides that the penalty for such offence shall be as may be prescribed by regulations, the penalty for every such offence shall, on summary conviction, be a fine not exceeding twenty thousand dollars or a term of imprisonment not exceeding two years, or both such fine and term of imprisonment.

Commencement.

6. These Regulations shall come into force on the 1<sup>st</sup> day of November, 2010.
